

Captain's Meeting #3 Spring 2017: 5/11/17 Start time 7:07pm

Roll Call: All teams present EXCEPT for Rommel's team (B8) and Trip's team (B1)

Board Members Present: Brook, Charlie, CJ, Rich, Judy, Christina, Cori

1st item of business

New Sponsor: Brook announced that Trip's team will not be moving to a new sponsor and will be staying at Muldoons. She also reiterated from the Board meeting that as a league we need to preserve our relationships with our founding bars on Broadway and keep teams out of those bars to protect our members and our players. We have openings at the Mineshaft and Sweetwater. We need to grow our league and venture out without losing our core.

Treasurer report (Cori):

- BCA dues for 3 new players accrued \$45.00
- Sudden Death fundraiser earned \$349.00
- Golf Tournament fundraisers earnest \$329.00 plus \$20 donation
- Our ending balance for the season is \$18, 441.98 (that will go toward West Coast in San Diego as well as when we host 76 next season, deposits for the hotel and Gibby are already paid)
- Income for fundraisers is down, donations were down over the course of the year
- The league also accrues money for using the link on the league webpage for Amazon
- The league needs donations for the raffle when we host WCC 76

- Janet brought up voting on the two proposals that were introduced in the first captain's meeting (Mike Valery's proposals)
- Brook introduced the following proposal to be voted on:

1.3.3 Duties of the Board of Governors

I. Take appropriate action with respect to teams or individuals who violate league rules or whose conduct is deemed detrimental to the league. Should an individual be suspended from seasonal play three (3) times, the final third suspension will equal permanent expulsion from the league. The suspended member has the right to appeal the decision at the next captain's meeting for final ruling. In extreme cases: the board has recourse to permanently exclude an individual from the league membership if they have been found to willingly commit a grievous misconduct such as, but no limited to, fraud and physical violence. Any suspensions prior to the beginning of the Fall of 2010 season will not count.

Proposal

Take appropriate action with respect to teams or individuals who violate league rules or whose conduct is deemed detrimental to the league. Issues may arise that are not expressly written or covered in the rule book. The BOG has the right and is expected to govern by applying the *spirit of the rules and sportsmanship* to make decisions that are not otherwise specifically stated within the rules. If an individual is suspended from seasonal play three (3) times, the final third suspension will equal permanent expulsion from the league. The suspended member has the right to appeal the decision at the next captain's meeting for final ruling. In extreme cases: the board has recourse to permanently exclude an individual from the league membership if they have been found to willingly commit a grievous misconduct such as, but not limited to, fraud, physical violence, acts of hatred or ongoing and continued harassment and defamation.

2/3 of the captain's vote yes is needed which is 12/18 and the proposal only received 9 votes for Yes.

• The next proposal Brook introduced for vote was:

The rule below is unclear. As written you only have to be responsible for two weeks. The proposal below is an explanation of what a member in good standing should be. BOG members should be people who follow through with the commitments and the rules of the league. Why elect individuals who have a track record of not being responsible or following through on the requirements of the job. We want our league to continue to run smoothly and be solvent for a long time.

1.3.1 Election and Term of Office

A. Nominations for the Board of Governors shall be open to all league members in good standing for a minimum of two (2) weeks prior to the elections.

Proposal 1

A. Nominations for the Board of Governors shall be open to all league members two (2) weeks prior to the elections. The nominated members allowed to participate must be in good standing. "Good Standing" is defined as participants whom are paid in full and who have held themselves in a sportsmanlike and responsible manner.

OR

Proposal 2

A. Nominations for the Board of Governors shall be open to all league members two (2) weeks prior to the elections. The nominated members allowed to participate must be in good standing. "Good Standing" is defined as participants whom are paid in full and who have held themselves in a sportsmanlike and responsible manner. Individuals that repeatedly resign from the BOG (3 or more times) and/or have been previously removed from the Board for Malfeasance and Nonfeasance (See 1.3.3 S Duties of the Board of Governors) should not be allowed to run for office.

- Mike Valery's proposal from the first meeting was retracted according to Brook
- Team playoff schedule will be announced
- #1 seed and #8 seed will play at Broadway Bar, Seed #4 and #5 will play at the Brit, Seed #3 and #6 will play at the Mineshaft and Seed #2 and #7 will play at Lakewood
- Richard mentioned this is Trip's 2nd missed captain's meeting and he will not be allowed to captain the team next season
- Janet wants a proposal to change the rule about presenting proposals to all captains in paper form, the meeting minutes should suffice
- Luke brought up an issue about a player on Cori's team telling Tina's team that he was sick and asked to play all four of his games consecutively. Tina's team agreed to it and it was later revealed this "sick" player actually left so he could play in a tournament at another location. Luke thinks it's an ethical violation and wanted to bring it up to the captain's. There is no rule on this conduct in the rule book. So the league cannot enforce any action against this player. The team and other league members have since talked to him and that player has apologized.
