1. Financials

2. Release of liability forms

3. WCC

- a. Congrats to the winners
- b. Location sourcing for WCC 2022. Chris is talking to The Hilton. Concedes is to look for other venues and try to get the best deal. Everyone agreed The Hilton was very good (storage room, pool, beds...), but to still look for other options.

 - i. Help us negotiate a better price
- c. New table owners of Gibbi's tables
 - i. Vote was cast. All captains present voted yes to use the new owners for to WCC cycles

4. Melissa, Rulebook/Rewrites/Proposals: See attachments

- a. The RBC is Melissa, Grant and Mike Valery.
- b. Melissa explained the rewrites to the rulebook were mostly clarifications of the rules, organization and spelling errors. No major changes. Captains need to review and vote at next meeting
- c. 3 proposals to vote on.
 - i. The about number of forfeits aloud in one season
 - ii. Rules about team playoffs
 - iii. Removing the gender language

Votes will be table for next captains meeting due to lack of informed captains.

Proposals and "Working Rulebook" with highlighted sections will be sent to each captain. Mike clarified the highlighted areas of the Working Rulebook and Grant explained some inconsistencies that needed to be changed. After reading the Working Rule Book, captains will be able to express any concerns, questions, complaints at the next captains meeting. The changes to the rule book with be voted on in its entirely.

5. Ken Franck:

- a. Chris addressed Ken's history of harassment to players and BOG members
 - i. Ken has already been suspended once for harassment
 - ii. Presented the text messages print outs of Cori and Jeff to the captains
 - iii. Ken was given a verbal formal warning; behave or be expelled

6. Open Floor:

a. Tina Thompson asked question about the realignment of the BOG

- i. Three BOG members quit; Van, Mark Reyes, Tina Thompson were replaced by Colleen Dinnie, Cori Ortiz and Rommel Salas
- b. Charlie Tripp asked when Todd and Steve taking over the tables will Gibbi still have a booth at the WCC, if so, what are we going to charge him . . .
 - i. Good question, the BOG will have think about that and get back with an answer
- c. Julian Salazar wanted clarification on the forfeit rule
 - Melissa, Charlie and Cori explained that forfeits will turn into byes if the forfeiting team has two nights or 32 games forfeits.
 More clarification will be giving later
- d. Julian Salazar asked about practice play during tournament
 - i. It's not in the rule book now, it has been understood that during team playoffs and other tournament there is no practicing once the matches begin. Charlie explained this was in the rule book at one time and then it wasn't. The RBC will be reinserting this rule back into the new rule book
